MINUTES

LBHA Board and General Meeting June 21, 2017

Meeting was called to order by Maureen at 6:30 pm. The following Board members were present: Maureen Henderson, Janis Rau, Kathy Dombrowski, Sherry Debaere, Flor Faoro and Greg King. Not Present: Melanie Warlow, Barbara Heyward and Dave Faoro.

The first order of business was the proposed bike pump track in Auburn. Pat reported on the status of the Western States Pioneer Express National Recreation Trail which starts at Beals point and continues 50 miles up through the bike park to Auburn and onto Foresthill. The Jedediah Smith National Recreation Trail is 26 miles that has two separate tracks one dirt for horses one paved for bikes goes from Sacto to Beals Point in Folsom. The confusion has occurred because these trails are not accurately described in State Park General plans, Bureau of Rec Management plans, Parks maps or brochures. These trails are being broken apart and their national status is simply lost to the public. Our goal is to protect these trails as the entire entities that they are and to enhance and popularize their status as 26 and 50 mile continuous trails which are part of the National trail system. Grant money can be made available to these trails if so recognized. Maureen H. made a motion that LBHA write a letter to the appropriate parties outlining the above. The motion was seconded by Greg K. The motion was voted on and passed unanimously.

The next order of business was discussion on the Sacramento Riverpark proposed bicycle pilot program. Maureen reported that it appeared the decision had already been made that the proposal will proceed. Jane Brown had further comments as she previously worked for the City of Sacramento. It was determined that we would not make an appearance at the upcoming public hearing scheduled for June 22, 2017.

Greg K. reported on the Loomis Basin Equine Health Fair. It was very positive, drawing a large attendance. Definitely want to consider having a booth there again next year. May consider putting together a nice display for our organization.

Maureen reported that she will be unable to coordinate the upcoming horse/bicycle clinic on September 17. Liz D. volunteered to oversee the event. Discussion was held concerning the \$20 entry fee. It was determined that we will charge \$20 and that participants must rsvp no later than September 1. For new members we will charge a membership fee and \$5 participation fee, since it will be so close to the end of the year.

Our guest speaker, Sonja Conklin, Membership Manager for AirMedCare NETWORK membership provider for REACH Air Medical Services & CALSTAR spoke to the membership about the changes which had taken place with CalStar. Greg K. made a motion that LBHA sign a membership agreement so that our members can receive a \$10.00 discount. The motion was seconded by Kathy D. The motion passed unanimously. Brochures and membership forms were passed out to members present. We will send out an email to the membership advising how to either renew or join to get the \$10.00 discount.

The next meeting will be held on Wednesday, July 19, 2017 at Round Table in Loomis. Eat at 6:00 pm, meeting at 6:30 pm.

The meeting adjourned at 8:00 pm.

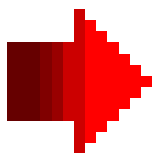

ARENA:: Please NO TRAILERS or HORSES on the asphalt parking lot. ALSO, no barrels, poles or other equipment may be used in the arena. Small Orange cones are OK. Trainers must have an Arena Use form submitted annually as well as the proper insurance naming LBHA and Placer County as "Also Insureds." If Insurance is cancelled 2 times or more, the permit is no longer valid. Trainers MUST contact LBHA with the time and number of students that will be in class, 24 hrs before the lesson. (All Forms are on LBHA Website at LBHA.us)

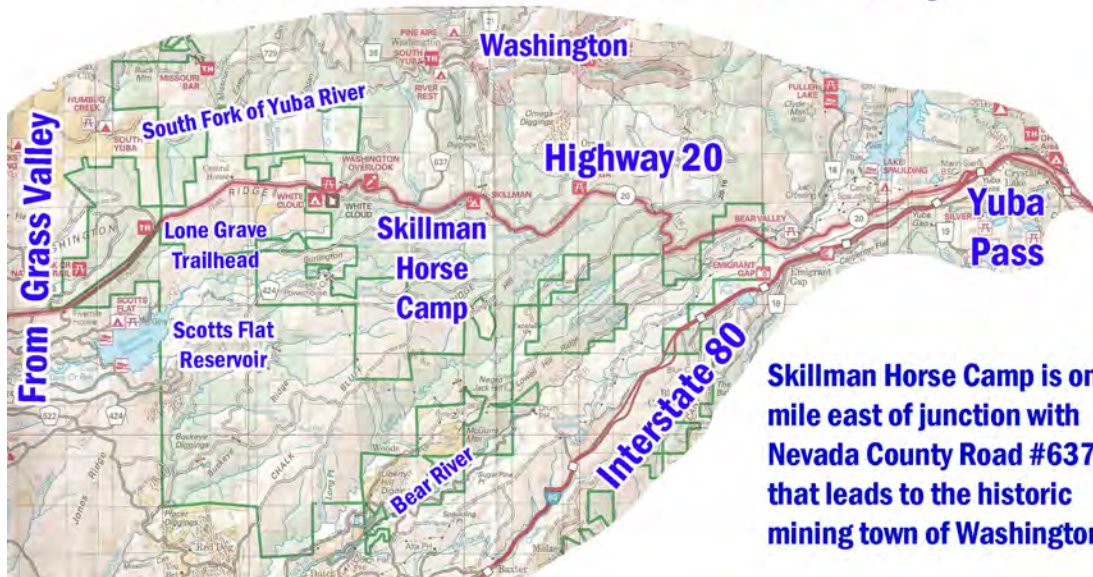

Tahoe National Forest

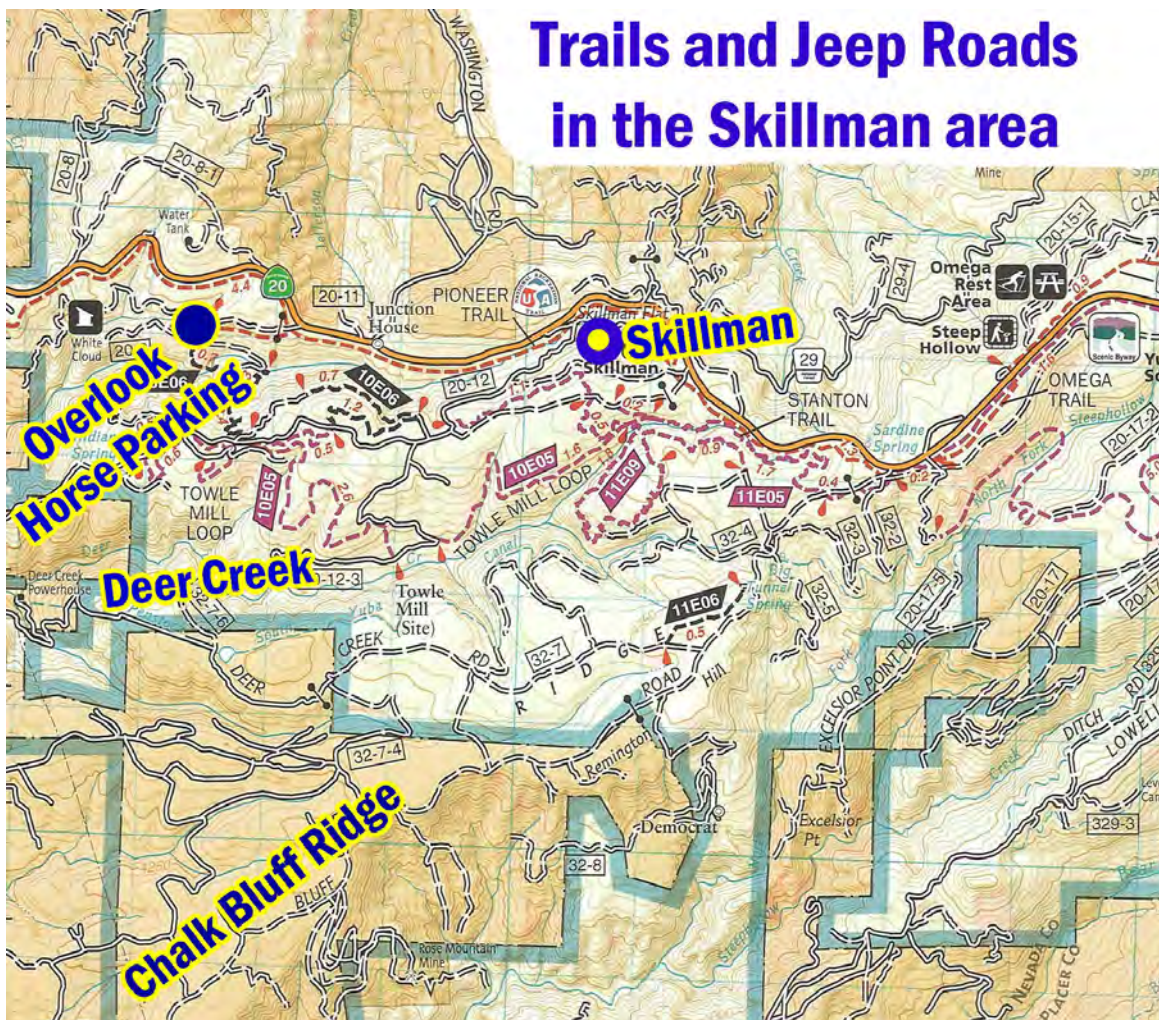

Skillman Horse Camp on Highway 20 is about 13 miles east of Grass Valley



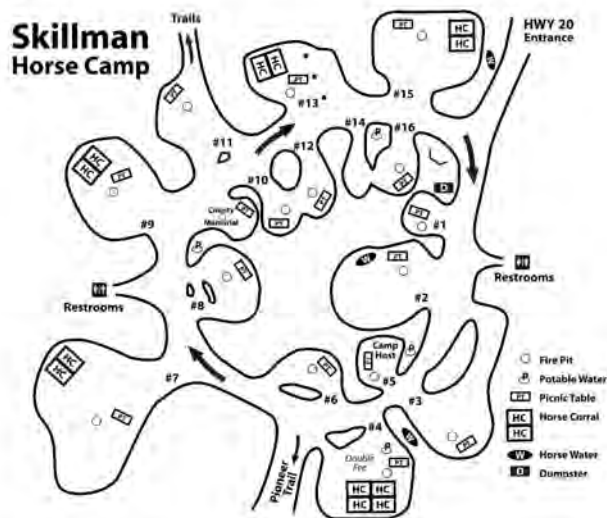
Trails and Jeep Roads in the Skillman area

Skillman Horse Camp is located about **13 miles east of Nevada City** along Highway 20 in central Nevada County, California. The horse camp is located along the **historic Pioneer Trail**. It is a popular horse camp because it is relatively cooler at elevation 4,500 feet and is located in a shady forest, compared with hot summer weather in the Sacramento Valley.

This is a self-registration fee-based horse camp @ \$18 per day within Tahoe National Forest.



Skillman Horse Camp is typically used and maintained by equestrians who belong to the **Gold Country Trails Council**. The detailed map of the camp with campsite numbers was prepared by GCTC.

To better inform the equestrian community and promulgate sustained support, GCTC has created a Facebook page for Skillman Horse Camp. GCTC has work-days each spring to maintain Skillman Horse Camp and nearby horse trails in preparation for the three-day **“Wild West Endurance Ride”** that is sanctioned by the American Endurance Ride Conference, www.aerc.org

The AERC Ride Manager is Robert Ribley, and the AERC Head Veterinarian is Dr. Melissa Ribley. More than a thousand riders have enjoyed the three-day “Wild West Ride” in the past several decades. These are both limited distance and 50-rides, and it is possible to ride 150 miles in three days. It is a well-organized ride on an extensive network of horse trails in valleys and ridges within a shady forest of ponderosa pines, cedars, and oaks.

Day Riders at the "Overlook" Equestrian Staging Area

About one mile west of the Skillman Horse Camp is a large equestrian staging area that is typically used by day riders because it is free. There are no hitching posts, no water supplies, and no restrooms. It is simply a large gravel parking lot with sufficient turning space for horse trailers. Reservations are not needed, and there is no fee for day-use. The one-lane gravel driveway from Highway 20 is one-half mile long.

This staging area is only open in the summer months, from May 15 until November 15. There is a locked gate for the winter months when this parking lot is typically snowed-in.

The "Overlook" Equestrian Staging Area is also used for extra space when there are large events at Skillman Horse Camp with over 100 horses. The name is from the nearby Highway 20 "Overlook" that was constructed by Caltrans and Tahoe National Forest.

Three separate horse trails lead in and out of this equestrian staging area, including the historic Pioneer Trail which connects with Skillman Horse Camp.

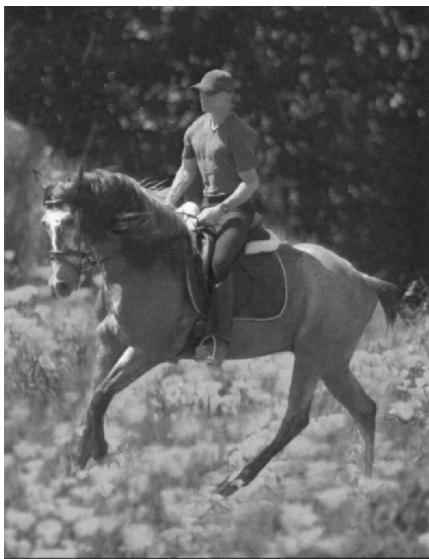

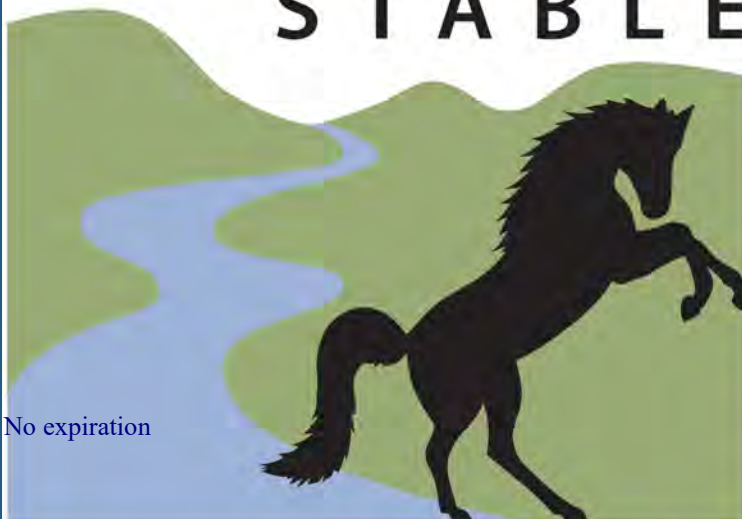

RELEASE AND HOLD HARMLESS AGREEMENT

The Undersigned assumes the unavoidable risks inherent in all horse-related activities, including but not limited to bodily injury and physical harm to horse, rider and spectator. The Undersigned acknowledges that horse-related activities are dangerous and that horses themselves have unpredictable temperaments which can sometimes cause injury. The Undersigned acknowledges that even the most experienced horse event sponsor, participant or horse owner cannot predict how each individual horse will react in a variety of situations and cannot guarantee my safety. THEREFORE, BY SIGNING BELOW, I KNOWINGLY ASSUME THE UNAVOIDABLE RISKS INHERENT IN ALL HORSE-RELATED ACTIVITIES, WHETHER KNOWN OR UNKNOWN, INCLUDING BUT NOT LIMITED TO BODILY INJURY AND PHYSICAL HARM TO HORSE, RIDER AND SPECTATOR, AND AGREE TO THE FOLLOWING ON BEHALF OF MYSELF AND MY SPOUSE, IF ANY:

1. I HEREBY RELEASE AND DISCHARGE LOOMIS BASIN HORSEMEN'S ASSOCIATION ("LBHA"), THE LBHA BOARD OF DIRECTORS, ALL LBHA OFFICERS AND INDIVIDUAL CLUB MEMBERS AND THEIR AGENTS, EMPLOYEES, OR REPRESENTATIVES, AS WELL AS PLACER COUNTY, (HEREINAFTER COLLECTIVELY KNOWN AS "RELEASEES") FROM ALL ACTIONS, CLAIMS OR DEMANDS I MAY NOW OR HEREAFTER HAVE FROM INJURY, DEATH OR DAMAGE RESULTING FROM MY PARTICIPATION IN ANY HORSE-RELATED ACTIVITIES SPONSORED BY LBHA, AT LOOMIS BASIN HORSEMEN'S ARENA OR AT ANY OTHER LOCATION.

2. I also EXPRESSLY WAIVE any rights I may have under California Civil Code §1542, which states: "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor."

5. I agree that I will DEFEND, INDEMNIFY AND HOLD HARMLESS Releasees against all claims, demands, and causes of action, including court costs and actual attorney's fees, arising from any proceeding or lawsuit brought against them due to any act done by me, or brought by me or for my benefit.
