

Membership Meeting Minutes March 15th, 2017

Meeting was called to order by Maureen at 7:10 pm. The following Board members were present: Maureen Henderson, Janis Rau, Kathy Dombrowski, Sherry DeBare, Melanie Warlow, Flo Faoro and Dave Faoro. Committee Chairpersons present were: Liz Daffner . Not Present: Greg King and Barbara Heyward. Janis Rau acted as Secretary for the meeting.

Janis made a motion that the new mounting block for the Arena be placed at the northeast corner on the outside. The motion was seconded by Kathy D. The motion passed unanimously.

Kathy D. reported on the status of the plaque for Jerry Potter at Traylor Ranch. She further reported on the status of the nature trail at the Arena. The creek trail is very eroded. Trees are down and extensive repairs are needed. The trail will be closed until the repairs are complete. The County will be spraying again for Pokeweed. She further reported on some plastic pallets she had found on Craigslist. It was motioned and seconded that we purchase 12 pallets. The motion passed unanimously.

Dave F. reported on Traylor Ranch. Some individuals have asked to pay for and put benches in a few places. Placer County has a standard design which can be purchased which also includes a monument option. The next work day will be Saturday, March 25.

Liz D. reported on the upcoming events for 2017. The first obstacle day is coming up in April. She and Kathy D. are working on getting a new bridge to use at these events. No dates yet for the Kathy Roberts' cow clinics. All events are listed on Facebook and the LBHA website. Liz reported there were some problems with Paypal so online registration is on hold right now. Liz had previously asked the board for \$120 to pay for an annual subscription (1/2 off for the 1st year) to be able to enable the Wix Booking App. That special offered expired the next day so she did not proceed with that purchase.

Maureen reported that Victory Velo Bike Shop in Auburn has agreed to partner with us for the horse/bicycle clinic onSeptember 17. We will drop the price from \$20 to \$10 per person to encourage more attendance, but still make enough money to cover lunch for the bicycle volunteers. We will have people register ahead of time so we know how many bicyclists we need to participate.

Pat Gibbs attended the Placer County Park and Trail Master Plan Focus Group Meeting put on by Design Workshop. She submitted her comments on that meeting in writing and they were passed out at the meeting. A copy is attached to these minutes.

The meeting adjourned at 8:15 pm.

ARENA:: Please NO TRAILERS or HORSES on the asphalt parking lot. ALSO, no barrels, poles or other equipment may be used in the arena. Small Orange cones are OK. Trainers must have an Arena Use form submitted annually as well as the proper insurance naming LBHA and Placer County as "Also Insureds." If Insurance is cancelled 2 times or more, the permit is no longer valid. Trainers MUST contact LBHA with the time and number of students that will be in class, 24 hrs before the lesson. (All Forms are on LBHA Website at LBHA.us)

Pride is no longer doing maintenance, now have a new company that knows what to do. A new sign up has gone up on the trail for Trail Right of Way. Horses have the right of way. The swing over the creek is gone. The pile of red dirt in the gravel parking lot before the red gate was dumped with out permission. As soon as Roads can get to it they will remove it. Dedication of New Equine Reproduction Center named in Honor of Dr. Robert Morgan, D.V.M.



The Loomis Basin Equine Medical Center has constructed a new 5,000 square-foot equine reproduction center. The construction occurred in Summer & Autumn 2016, and was completed in December 2017.

On Wednesday evening, March 22, 2017, a formal dedication was held in honor of Dr. Robert Morgan, a long-time senior partner in the firm. About 150 equestrians attended the gala event, representing a number of local horse societies.

The dedication event included a complimentary supper, a speech by Dr. Bob Morgan about his four-decade career in equine medicine, a lecture by Zoetis Pharmaceuticals on their equine vaccination program, two veterinarian medical lectures using Powerpoint on contagious diseases (by Dr. Langdon Fielding, and Dr. Diane Rhodes), and tours of the new facility. The equine reproduction facility has twelve spacious foaling stalls for pregnant mares.





















4 Misconceptions About Alfalfa

Despite all the science-backed suggestions about feeding alfalfa, it remains a misunderstood forage. The following are a few misconceptions worth clarifying.

Myth: An alfalfa-rich diet causes kidney problems.

"A normal, healthy horse can metabolize and excrete the extra protein in alfalfa just fine, if the horse has adequate water," says Ray Smith, PhD, forage extension specialist at the University of Kentucky, in Lexington. Horses with kidney disease shouldn't consume a high-protein diet (such as alfalfa), but the alfalfa itself won't cause kidney disease.

Myth: Alfalfa makes horses hyper.

"I don't think there is any scientific basis for this," says Krishona Martinson, PhD, associate professor and equine extension specialist at the University of Minnesota's Department of Animal Science, in Falcon Heights. "Alfalfa does have more energy compared to grass hay of similar maturity, so perhaps a horse eating a lot of alfalfa in the absence of exercise may have more energy. The biggest issue with alfalfa, however, is weight gain in horses that don't have adequate exercise."

Myth: Alfalfa has high nonstructural carbohydrate (NSC) levels.

"Cool-season grasses like timothy, bromegrass, and orchardgrass actually have higher nonstructural carbohydrate content and sugars than legumes," says Martinson. "Horses with carbohydrate sensitivity (e.g., obese horses, those with laminitis, equine metabolic syndrome, equine Cushing's disease, or polysaccharide storage myopathy) need their diet carefully monitored for nonstructural carbohydrates and can benefit from including some alfalfa rather than grain or cool-season grasses."

Myth: Alfalfa aggravates respiratory problems in horses with heaves.

Some horses tend to cough more when fed alfalfa, but this is due to irritants such as dust and mold rather than the alfalfa itself. Alfalfa can be dustier than grass hay when moisture conditions at baling are less-than-ideal. Alfalfa leaves also tend to shatter when too dry, creating more dust particles.

"Mold formation is also related to moisture content when baling," says Martinson. "One issue with alfalfa—which tends to have more stem than grass—is that the stem takes longer to dry. Alfalfa might take 12 to 24 hours longer to dry than a grass crop, simply because it has more stems. Moldy grass hay or moldy alfalfa hay both cause airway irritation when mold dust is inhaled."

Take-Home Message

The horse industry is full of misconceptions about alfalfa. Before dismissing this nutrient-rich forage, contact your veterinarian or equine nutritionist to develop a feeding program that's right for your horse.







THEREFORE, BY SIGNING BELOW, I KNOWINGLY ASSUME THE UNAVOIDABLE RISKS IN-HERENT IN ALL HORSE-RELATED ACTIVITIES, WHETHER KNOWN OR UN-KNOWN, INCLUDING BUT NOT LIMITED TO BODILY INJURY AND PHYSICAL HARM TO HORSE, RIDER AND SPECTATOR, AND AGREE TO THE FOLLOWING ON BEHALF OF MYSELF AND MY SPOUSE, IF ANY:
